

Data protection notices according to the general data protection regulation for visitors

With the following information, we would like to comply with the obligation to provide information according to Article 13 of the General Data Protection Regulation ("GDPR").

1. Responsibility

The responsible within the meaning of the GDPR is the Brose company named in the e-mail signature.

2. Purpose of processing and legal basis

We process your personal data (name, contact data) for the purpose of visitor administration. The legal basis in the sense of the GDPR for the use of your data is Art. 6 para. 1 lit. f GDPR (justified interest of the person responsible). Our legitimate interests are in particular the safeguarding of domiciliary rights, comparison with sanctions lists and compliance with customs regulations.

In addition, in specific situations (e.g. in the case of official orders to prevent infection), further data may be collected from you. If this is the case, you will receive further information on the processing of your personal data when the data is collected.

3. Data transfer and storage duration

All data will be treated confidentially and stored in compliance with the applicable legal regulations. Your data will be stored for 12 months in order to fulfil the purposes described above. Within the Brose Group, only authorized persons and bodies receive your data.

Within the Brose corporate group, only authorized persons and bodies receive your data. Because Brose is a globally operating group of companies, it may also be necessary to pass on your data to other companies in the Brose Group, including those outside the EU/EEA, in order to fulfill the above-mentioned purposes. A uniform level of data protection is ensured by the existence of binding internal data protection regulations and the agreement of standard contract clauses for Joint Controllers.

We may also transfer your data to external parties (e.g. authorities, courts or legal advisors) if this is necessary to comply with legal obligations or to enforce, exercise or defend legal claims.

4. Your Rights

If our company processes your personal data, you have the following rights within the respective legal scope:

- Right of **access**, especially about the data stored by the responsible person and their intended use. (Art. 15 GDPR),
- Right to rectification of inaccurate or incomplete data (Art. 16 GDPR),
- Right to erasure, e.g. of unlawfully processed or no longer necessary data (Art. 17 GDPR),
- Right to restriction of processing (Art. 18 GDPR),
- Right to data **portability**, provided the processing takes place based on consent or to perform a contract or by means of an automated process (Art. 20 GDPR) and
- Right to object the processing based on Art. 6 para. 1 e) or f) GDPR if reasons arise from your
 particular situation (Article 21 GDPR). After revocation, we will only process your data if we can
 prove compelling reasons for processing worthy of protection, which outweigh your interests,
 rights and freedoms, or if the processing serves the assertion, exercise or defense of legal claims.
